Pool Rules and Safety Policy

Please read carefully and review with your family members as appropriate. Sign, date, and return this form to the Golf Course.

Swimming is **only permitted when lifeguards are on duty**.

Anyone found swimming **after hours** will have their **membership privileges revoked**.

Please always follow the directions of the lifeguards. Lifeguard instructions are final.

1. **Children Supervision**

All children must be accompanied by a parent, guardian, or sitter **age 16 or older**.

No exceptions. Anyone observed not adhering to this policy may have their membership privileges revoked in accordance with Health Department regulations.

2. **Food and Beverages**

All food and beverages (except during swim meets) must be **purchased from the Grill** and consumed in designated areas.

a. The Grill will be happy to provide a cooler with the purchase of beverages. **Personal coolers are not permitted on the pool deck**, except for medical purposes (such as insulin or other medications) and must be **pre-approved by Golf Course management**.

3. **Swim Diapers**

For sanitation reasons, children who are not toilet trained **must wear swim diapers or secured rubber/plastic pants with elastic legs**.

4. **Appropriate Attire**

For sanitation and safety reasons, **appropriate swimming attire must be worn at all times in the pool**.

5. **Glass Containers**

For safety reasons, **glass containers are not permitted in the pool area or on the pool deck**.

6. **Pets**

Pets are not permitted on the pool deck at any time.

7. **Injuries**

All injuries, no matter how minor, **must be reported to a lifeguard immediately**.

8. **Footwear**

Aqua socks, flip-flops, and other aquatic footwear are permitted on the pool deck. Street shoes may track

in glass or other unsafe debris; therefore, **please avoid wearing street shoes on the pool deck when possible.**

9. **Wheeled Equipment**

Skateboards, scooters, bicycles, or other wheeled devices **are not permitted in the pool area or on the pool deck.**

10. **Pool Safety**

For the safety of all patrons:

- **Walking only on the pool deck**
- **No diving**
- **No horseplay**
- **No pushing or shoving**

Failure to comply with these rules may result in **removal from the pool area and/or suspension of membership privileges.**

Management and lifeguards reserve the right to enforce all pool rules and may ask any patron to leave the pool area if behavior is deemed unsafe or disruptive.

Inclement Weather Policy

In the event of approaching severe weather, management may close the pool early for the safety of our members and guests and to allow staff to properly secure the pool deck and facility. If an early closure is necessary, members and guests will be notified at least **30 minutes in advance**. At the announced closure time, all patrons must exit the pool and pool deck area so lifeguards and staff may safely close the facility.

If **thunder is heard**, all patrons must immediately exit the pool and pool deck and seek appropriate shelter. The pool and pool deck will remain closed for **30 minutes from the last sound of thunder**, as determined by the lifeguard on duty.

If **lightning is seen**, all patrons must immediately exit the pool and pool deck and seek appropriate shelter. The pool and pool deck will remain closed for **30 minutes from the last sighting of lightning**, as determined by the lifeguard on duty.

For the safety of all patrons, **lifeguards and management have full authority to clear the pool and deck area and enforce this policy at any time weather conditions pose a potential risk.**

LIABILITY WAIVER, RELEASE, AND HOLD HARMLESS AGREEMENT

This Agreement is entered into between **Chesapeake Golf Club, LLC (“CGC”)** and the undersigned participant and/or parent or legal guardian of a minor participant.

By signing this Agreement, the undersigned acknowledges and agrees to the following terms:

1. Assumption of Risk

I understand that participation in swimming and use of the swimming pool and related facilities involve inherent risks, including but not limited to slipping, drowning, injury from other participants, equipment failure, or other hazards associated with recreational water activities.

I voluntarily assume all risks associated with participation in swimming activities and use of the facilities at Chesapeake Golf Club.

2. Release of Liability

To the fullest extent permitted by the laws of the Commonwealth of Virginia, I release, waive, and discharge **Chesapeake Golf Club, LLC**, its owners, employees, lifeguards, instructors, coaches, contractors, volunteers, agents, and affiliated organizations from any and all claims, liabilities, damages, or causes of action arising out of or related to participation in swimming activities or use of the pool and related facilities.

This release applies to any claims resulting from ordinary negligence of Chesapeake Golf Club or its representatives.

This release does **not** apply to gross negligence or intentional misconduct.

3. Indemnification

I agree to indemnify and hold harmless Chesapeake Golf Club, LLC and its representatives from any claims, damages, liabilities, costs, or expenses (including reasonable attorney’s fees) arising out of my participation or the participation of my minor child in activities at the facility.

4. Minor Participants

If signing on behalf of a minor, I certify that I am the parent or legal guardian and have the legal authority to execute this Agreement on the minor’s behalf. I acknowledge that I am responsible for the supervision and conduct of the minor participant.

5. Rules and Policies

I agree that I and all members listed under my family membership will follow the rules, policies, and safety regulations established by Chesapeake Golf Club for use of the pool and facilities.

6. No Refund Policy

Membership fees and related payments are non-refundable.

7. Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of the **Commonwealth of Virginia**.

8. Entire Agreement

This document represents the entire agreement between the parties regarding liability and use of the facilities. Any modifications must be in writing and signed by Chesapeake Golf Club.
